Please note the figures in the attached spreadsheet refer only to Kent, Surrey or Sussex patients, and not patients from other areas who are referred to the MBU. The reason for this is as follows:

The MBU service use a Referrals system called WebBeds. This is used nationally by MBU's. All referrals for MBU come through this system.

If the referral is for a patient in Kent, Surrey or Sussex, the referral is entered on the clinical system for the MBU admissions team. If the patient is outside of these counties, they are signposted to a closer MBU service.

Once a patient has a referral on the clinical system, they are screened as required, and the referral processed as per normal procedure.

I confirm that the information above/attached completes your request under the Freedom of Information Act 2000. I am also pleased to confirm that no charge will be made for this request.
